### CAPITAL PROJECTS UPDATE

## St. Marguerite Bourgeoys School

St. Marguerite has moved furniture into these areas at the end of June and will now need to set up the classrooms as work was still occurring in this area over the summer.

## St. Gregory the Great Catholic School

The exterior sheeting on the exterior building is complete along with floors poured on the second floor. Site work has started and expecting to have all the sidewalks and paving completed this fall.

### St. Joseph High School

The interior painting has started in a couple of areas and most of the exterior work has been completed. Work has started on the landscaping.

### St. Francis of Assisi Addition

The interior is complete with exception of a few minor item s yet to be completed. The exterior landscaping and new parking areas are not complete due to the wet summer. The contractor will be developing a plan to complete this in September.
