## Capital Projects Update

St. Marguerite Bourgeoys School

Work is continuing in the John Wilson portion of the building and planning to start the final phase which included the St. Marguerite library wing in the coming months.

St. Gregory the Great Catholic School

Site paving is complete. Interior floor grinding has been completed and most of the interior wall are installed on the second floor. The exterior block and metal siding is progressing along with the mechanical and electrical rough in.

### St. Joseph High School

The paving is almost complete and most of the trees planted. Work is continuing on the landscape prep. The learning pods are at the point of becoming dust free which means the floor protection will be removed, final coat of paint and ceiling tiles will begin to be installed.

### St. Francis of Assisi Addition

Work is continuing on the exterior work of the parking lot and landscaping.
