Capital Projects Update

St. Marguerite Bourgeoys School

Work is progressing in the last stage of the project. This work is expected to be completed in March.

St. Gregory the Great Catholic School

Painting has started on the second floor classroom areas and work to the remaining areas is progressing. The school is scheduled to be completed at the end of May.

St. Joseph High School

Substantial completion was obtained along with occupancy on Feb 7. The construction team will remain on site for the next couple of weeks to clean up any outstanding deficiencies. Furniture began to arrive on February 15.

Holy Trinity Modular relocation

The recent funding announcement did not include the relocation of the 4 modulars from Notre Dame to Holy Trinity. The school will be able to make it through the upcoming school year and re-application for the relocation of these unit to be in place for September 2018.

Our Lady of the Rosary Modular relocation

Work has begun on tender documents for the relocation of 4 modulars from Notre Dame The work will include the construction of a link, vestibule and some storage.

St. Elizabeth Seton Modular relocation

Work has begun on tender documents for the relocation of 2 modulars from Notre Dame. The funding announcement included the relocation of 1 modular. On January 31, the Board of Trustees approved moving the second modular unit using Capital reserve funding.
