8. DIVISION EXTERNAL AUDIT ACCOUNTABILITY REPORT

Annually, MNP provides the Board with a letter that assesses the quality indicators which are used in the evaluation process of fiscal management. The Auditors look for four quality controls as set out in the letter, and determine in each case if we have successfully completed each one. MNP gave the Board a favourable report on all four indicators.

9. SUMMER READING SURVEY RESULTS

The Associate Superintendent of Faith Development and Division Support presented Trustees with the Summer Reading Survey Results. Fifteen schools participated this year. Over 15,000 books were in the hands of 2,600 students over the past summer. The program continues to be an effective way to promote literacy.

10. ST. GREGORY THE GREAT AND ST. JOSEPH'S HIGH SCHOOL TOURS

Trustees will tour St. Gregory The Great Catholic School on February 28 and St. Joseph's High School on March 9.

11. CELEBRATION OF EXCELLENCE UPDATE

The Superintendent updated Trustees regarding the potential of the Celebration of Excellence moving back to a May date annually. This would better accommodate retiring teachers and Years of Service awards as these would then pertain to the current year. The ATA has expressed interest in continuing the current partnership which includes ATA induction.

12. 2016 ADMINISTRATORS' RETREAT

The Associate Superintendent of Faith Development and Division Support briefed Trustees on the Retreat held in October. Administrators focused on the development of leadership narratives to share strategies and improve practice amongst our administrators.

It was noted the annual retreat will move to February, 2018 for next year.

13. EDUCATION FOUNDATION "SPOTLIGHT" EVENT

The Superintendent and Trustee Hollman updated Trustees with regards to the March 16 event. Sponsors and VIP's will be invited for the 5:00 event and at 7:00 the doors will open to the public for the Spotlight Event showcasing students within the Division. The Education Foundation is currently advertising in schools and on social media encouraging current students to audition for this event.

14. FACILITY RENTAL RATES

The Supervisor of Support Services reviewed the after hour facility rates with Trustees and recommended some minor increases. The rates, which have not increased over the last seven years, were compared with neighboring divisions' rates. With the slight increase the new rates will now be consistent with neighboring boards but still below the provincial average.

15. POLICY REVIEWS - POLICY 8 - HEARINGS ON TEACHER TRANSFERS

As part of the Board's Annual Work Plan, Trustees had an opportunity to review Policy 8 - Teacher Transfers at the October Board meeting and discussed some changes. Policy 8, with revisions, was presented to Trustees.
