## 5. SCHOOL FEES

The Secretary-Treasurer updated Trustees on the current status of school fees with regards to Bill 1 - An Act to Reduce School Fees which was introduced by the government on March 2. Mr. Steeves indicated that if this Bill is passed, School Divisions will no longer be able to charge school fees for instructional supplies or transportation fees for students living over 2.4 km

from their home. The fees that would have been collected will be refunded to the Division by the government in the amount of approximately \$630,000 for 2017-2018 school-year.

6. POLICY REVIEWS - POLICY 18 - EARLY RETIREMENT ALLOWANCE

ASBA was highly involved in the 2009 creation of this policy and the Secretary-Treasurer is awaiting advice from them before

any

changes are possibly made. Since he has not yet received any information back, this Policy will be brought back to the April meeting.

St. Marguerite Bourgeoys School

Work is progressing in the last stage of the project. This work is expected to be completed by the end of March.

St. Gregory the Great Catholic School

Ceiling grid has started on the second floor, painting is occurring in all areas, gym floor hardwood is starting in April and all other work is progressing on schedule. The school is scheduled to be completed at the end of May.

St. Joseph High School

Construction is complete other than some seasonal deficiencies which will be addressed in the spring.

Our Lady of the Rosary Modular relocation

This project is currently out for tender with results expected by the end of this month.

St. Elizabeth Seton Modular relocation

This Project will be going out to tender shortly.

Fr. Henri Voisin Modular addition

Planning has begun on this addition. ABC School, as part of the P3 contract, will deal with all aspects of this project.
