7. POLICY REVIEWS - POLICY 4 - TRUSTEE CODE OF CONDUCT

Trustees reviewed and discussed Policy 4 - Trustee Code of Conduct. The Ministerial Order will be coming forward soon and Trustees felt that the Policy, as it stands, does not require changes at this time. Trustees will review it again when the Ministerial Order comes in.

8. CANADA WINTER GAMES

The Canada Winter Games will take place in February 2019 and RDCRS spring break will occur during the second week of the Winter Games (February 25 - March 1). The division will be handling a significant amount of transportation for athletes during the games. It was noted that both Red Deer Catholic Regional Schools and Red Deer Public School Division plan to work together to make the Winter Games a success. Staff in both divisions requesting leaves for Winter Games purposes need to be aware that leaves will be driven by their collective agreement.

9. STUDENT TRANSPORTATION ELIGIBILITY CRITERIA

The Supervisor of Support Services indicated that at this time there has been no change to the regulations regarding transportation funding and we await correspondence. At the present time the division participates with neighbouring boards with regards to cooperative bussing in Rocky Mountain House, Olds and Innisfail. The division currently subsidises bus passes for the City of Red Deer students riding public transit at \$4.00 per student per month which could increase substantially in the coming year if the transportation funding rate does not increase for school divisions.

CAPITAL PROJECTS UPDATE

St. Patrick Modernization

Work is continuing on the validation stage of the project. This stage involves the construction team putting budget numbers to the scope of work and adjusting what will be done according to these numbers. The final details of the exact scope of work will be formalized in mid March but we are proceeding based on the removal of 8 classrooms and the construction of 16 new classroom spaces as well as some modifications of the existing school.

Modular Requests

We are still waiting to hear on the status of our modular requests. Once this has been determined we will move forward with getting tender documents, development permits and building permits in place.
