#### CAPITAL PROJECTS UPDATE

#### St. Patrick Modernization

Currently work is continuing on the validation stage of the project, which involves the construction team putting budget numbers to the scope of work and making adjustments where required. The division is still working on the final details and will proceed with the removal of eight classrooms and the construction of 16 new classrooms, with some modifications to the existing school.

# **Modular Requests**

St. Matthew Catholic School will receive four modular classrooms. The development permits have been submitted and will go to tender in April. With the construction of a link, the completion date will likely be after school opens in the fall of 2018.

Fr. Henri Voisin School will receive three modular classrooms. ABC Schools, as part of the P3 agreement, will be taking care of adding the modular classrooms to the school.

École Our Lady of the Rosary School will receive two modular classrooms. A development permit for two modular classrooms in expected to go out to tender in April.

Holy Trinity Catholic School will receive two modular classrooms. The development permit for the two modular classrooms is expected to go out to tender in April. With the construction of a link, the completion date is likely going to be after school opens in September 2018.
