St. Patrick's Community School Modernization

The Structural Steel tender package closed under budget, this brings the team closer to being on budget. Foundation tender package is currently out with the final tender package expected to go out in July. Work will begin at the end of June.

St. Matthew Catholic School Modulars

Tenders for this project close on June 14.

Father Henri Voisin School Modulars

ABC Schools, as part of the P3 agreement, will be dealing with all aspects of this school. The manufacturer has informed Alberta Infrastructure that they will not be able to meet their expected delivery date which means the modulars will likely not be ready for the beginning of September and be pushed to mid-September.

École Our Lady of the Rosary School Modulars

The transportation and placement of the two modular classrooms approved for OLR has been awarded to Timcon Construction. We expect to see them on site prior to the end of June. The manufacturer has informed Alberta Infrastructure that they will not be able to meet their expected delivery date which means the modulars will likely not be ready for the beginning of September and pushed to mid-September.

Holy Trinity Catholic School Modulars

The construction of the link, transportation and placement of the two modular classrooms approved for Holy Trinity School has been awarded to Russpet Construction.
