## CAPITAL PROJECTS UPDATE

#### St. Patrick Modernization

Work is progressing on the new addition with all structural steel and concrete floor in place, roofing started and exterior walls constructed. Work will continue with the interior walls, mechanical and electrical work. We remain on schedule and trending under budget which will allow us to add the admin suite revitalization into the scope of work.

### St. Matthew Modular addition

The modulars are expected to to be ready for occupancy by the end of November.

### Montfort/Cultural Services

The initial program requirements identification has been completed and it has been determined that the IT and Finance departments will be relocated to the cultural services building. Specific space planning will begin shortly with both those that are relocating and those that are remaining at Montfort. A facility naming process will begin with the Board in the near future.

### Playground Pilot Program

After review with the City of Red Deer who maintains and inspects our playgrounds within city boundaries, no playgrounds within the city of Red Deer are due for replacement prior to 2023. Our maintenance team, who maintains and inspects our rural playgrounds, has indicated that the playground located at St. Marguerite is in need of replacement. A submission will be made to the pilot program for the replacement of the St. Marguerite playground.
