CURRICULUM COORDINATOR PROPOSAL

In order to streamline and make more efficient the development of Alberta curriculum and resource coordination for Catholic schools, trustees and CCSSA are being asked to consider the creation and implementation of a Curriculum Coordinator role. The Superintendent and Associate Superintendent of Faith and Division Support spoke to this item and provided trustees with a funding breakdown. Trustees expressed their desire to support the proposal.

4. ACSTA BYLAW REVIEW PROCESS

Trustee Pasula brought forward the proposed ACSTA bylaws and sought feedback from trustees. With the feedback provided he will do the ACSTA survey monkey on behalf of trustees.

TENDER APPROVAL

Red Deer Catholic Regional Schools sent out tenders for the modernization of Cultural Services and Montfort Centre. The tenders closed with the following four bidders:

- Pearl Rose Construction Ltd.
- Chandos Construction Ltd.
- Sunda Consulting & Construction Management
- Emcee Construction & Management Ltd.

The project construction estimate was \$2,731,000 including a construction contingency. The bid from Emcee Construction & Management Ltd. Of \$2,440,000 plus a 10% contingency gives a total construction value of \$2,684,000 which is \$47,000 under the pre tender estimated cost.

9. MEETING WITH MINISTER LAGRANGE

The Board will have the opportunity to meet with the Minister of Education on June 14. Trustees proposed several topics to discuss with Minister LaGrange and will prioritize the items to make up an agenda.

10. ADVOCACY

- AHS, Red Deer Public School Division and RDCRS met in February on the issue of lack of funding for mental health in the Red Deer area. Chair Watson proposed that a letter be sent once again to the Education Minister, Health Minister and Associate Minister of Mental Health in this regard.
- MELT information was provided on the current cost of the MELT program amounting to approximately \$55,025 for an increase of \$34,315 for the upcoming year. The RDCRS bus driver training program pre-MELT was significantly higher than many school boards in the province so although there is an increase in cost, it is likely not as much of an increase as many divisions are experiencing at this time.

 Chair Watson recently received a phone call from MLA Sarah Hoffman who is the newly appointed Education critic and the Chair had the opportunity to share some of the board's important advocacy issues.

St. Patrick's Community School Modernization

Phase two is nearing completion and turnover date for the school is scheduled for June 28. This date will allow students to finish the school year and complete their exams without disruptions caused by moving to a new location.
