#### CAPITAL PROJECTS UPDATE

On June 15 we held our first planning meeting which included two individuals from Alberta Education and three from Alberta Infrastructure. The delivery method will be a Jurisdiction delivered, design, bid, build. There will be an agreement forthcoming with the \$2.0 M design dollars. The school building will have a capacity of 537 students and will include 8 modular units to bring the capacity to 737 students. The permanent facility will be 5,913 square metres. Once the design is completed we will be provided the additional funding shortly as they see this as one of the top priorities.
