3.2 VACCINATION RAPID SCREENING PROGRAM

Delegations were read from two people in attendance. Mr. Fred Simoni read a letter aloud to trustees opposing a mandatory vaccination program. Lydie (first name only) presented on behalf of the RDCRS United Staff for Freedom also opposing a mandatory vaccination program for staff.

Chair Pasula read aloud an anonymous letter representing staff who are also against mandatory vaccinations and rapid tests.

The Associate Superintendent of Personnel presented the findings from the recent staff survey. The survey was completed by 647 staff members and the results were shared with Trustees. He highlighted that 82.4% of staff are or plan to be fully vaccinated by November 4, 2021 and that 70.3% of staff support mandatory vaccination or rapid testing.

Trustees had the opportunity to ask administration several questions which led to a rich discussion. After much debate and discussion the Board felt more information was needed.
