3. ACTION ITEMS

3.1 TRUTH AND RECONCILIATION CALLS TO ACTION

 - RDCRS is focused on dual credit and the partnerships we have and continue to experience growth in dual credit enrollment.
- 4.3 Financial Report Highlighted in the report:
 - We remain at a \$3.3M surplus to date and expect to be well under budget at the end of this fiscal year. Much of the reason for the surplus is due to the unexpected federal money that was received and Trustees thanked and acknowledged the federal government for the funds.

Mr. Sawula, Division Principal, spoke to the 2020-2021 Schollie data. Trustees felt that the Schollie data results were outstanding especially in a pandemic year like this.

- 4.5 St. Lorenzo Ruiz Design Team Update Highlighted in the report:
 - The build is currently running over budget due to cost increases in many areas (lumber, steel, etc).
 - The Secretary-Treasurer reported that he was working with the IPD Team to seek cost reductions and call on Alberta Infrastructure given the situation in the marketplace to seek additional construction funding.
