# 6. INFORMATION ITEMS

6.1 <u>Superintendent Report</u>

A written report was presented by Superintendent Finnigan and reviewed by Trustees. Superintendent Finnigan commended Religious Education and Curriculum Support Lead Teacher JoAnn Kelly on her suggestions for the Catholic Education Sunday suggestions. The first outcome of the RDCRS Education Plan, Students are Successful, was discussed. A monthly news release will be created after each board meeting.

6.2 Alberta Education Survey Executive Summary 2021-2023

Superintendent Finnigan provided Trustees with an update on the Alberta Education Assurance Survey. Associate Superintendent Sawula provided an oral snapshot of the Schollie and Alberta Education Assurance (AEA) Survey. Administration indicated that they aim to increase parental involvement and have targeted to improve the three-year and five-year high school completion rates.

### 6.3 <u>Student Enrolment Report</u>

Trustees reviewed a written report provided by Secretary Treasurer Steeves on student enrollment for the 2022-2023 school year. The report showed that student enrolment has grown by 1.29% in total students and 1.57% in Full-Time Equivalency (FTE) over the 2021-2022 school year.

# 6.4 Financial Report

Secretary Steeves presented a written financial report to Trustees, outlining the statement of operations, expenses by object, balance sheet and the St. Lorenzo Ruiz budget. Steeves shared that the St. Lorenzo project is currently on schedule and on budget.

# 6.5 Capital Projects Report

Secretary Treasurer Steeves updated Trustees about the St. Lorenzo Ruiz capital project and shared that the Division continues to work towards the goal of construction completion by June of 2023. Steeves also provided an update on projects happening at Ecole Secondaire Notre Dame High School, St. Francis of Assisi, St. Gregory the Great, St. Thomas Aquinas, St. Joseph High School, St. Patrick's Community School, Our Lady of the Rosary and St. Matthew Catholic School.
